Cemented with 10 bfw, 500 gallons Mud Clean, 10 bfw, 1100 sx Super "C" modified with 1.1% FL-25, 3# LCM-1 (s.w. 14.2 ppg, yield 1.30 ft3/sx). Batched mixed slurry. Displaced with 5% KCl water containing packer fluid. Plug down at 7:30 pm CDT 10-21-04. Top of cement at 5800' per temperature survey.
