January 2005 - MI&RU. TOH with injection packer and PC injection tubing. Packer is nickel plated SL tension. Circulate hole clean to 3338'. Pull Bond Log from TD to surface (attached). Add perfs in unit interval from 3002-3311' (115 holes, 1 SPF). Acidize unit interval with 7000 gals 15% NeFe HCl + balls. RIH with packer and PC injection tubing to 2900'. Circulate packer fluid and set packer.

MIT tested to 500#, held okay. Test witnessed by NMOCD representative, Gerry Guye. Original chart retained by NMOCD.
