Spud well on 5/12/11. Drilled 12-1/4" hole to 464'. Landed 8-5/8" 24# J-55 csg @ 447'. Cmted lead #1 w/100 sx (163 cf) Thixotropic "C" cmt w/10# kol seal, 0.125# PE flake, 10# gilsonite, & 1% Cacl2 & lead #2 w/275 sx (371 cf) "C" cmt w/2% Cacl2, & 1/8#/sx pe-flake. Tailed w/200 sx (264 cf) "C" cmt w/2% Cacl2. Did not circ cmt to surface. Tagged TOC @ 86' & topped off w/redi-mix to surface. On 5/13/11, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5261' on 5/25/11. Ran open hole logs. Landed 5-1/2" 17# J-55 csg @ 5245'. Cmted lead w/550 sx (1045 cf) 35/65 poz C cmt w/0.125#/sx pe-flake, 3#/sx salt, 0.5% Halad-9, & 3#/sx gilsonite. Tailed w/650 sx (865 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, 0.5% CFR-3, & 1/4#/sx D-air. Circ 99 sx cmt to pit. Released drilling rig on 5/26/11. Plan to pressure test the 5-1/2" csg before completion operations.
