Now plan to cement with lead 200 sx Class C + 10% W-60 + 1% CaCl₂ + 0.25% R-38 + 5# Gilsonite per sx, 14.4 ppg, 1.56 cuft/sx, 7.04 gal/sx fw and tail 200 sx Class C + 2% CaCl₂ + 0.25% R-38, 14.8 ppg, 1.35 cuft/sx, 6.34 gal/sx fw. Excess 100%.
