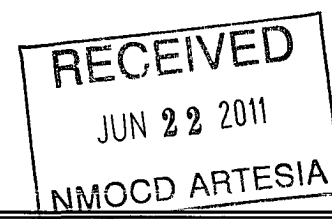

Tailed in with 210 sx Premium Plus "C" + 1% CaCl (yld 1.34, wt 14.8). Circulated 432 sx to pit. Tested casing to 1500 psi for 30 min. WOC 48 hrs 50 min. Reduced hole to 8-3/4" and resumed drilling.
