Halliburton pumped 150 sks Class C cement w/10% Thixotropic mix then 450 sks "C" W/2% CaCl. Cement did circulate to surface. Notified BLM of cement time. BLM was a no show. WOC required time. NU hydri, GIH w/bit & drill pipe, Test all to 1000 psi for 30 mins-held ok.

10/22/04 Run total of 116 jts (5416') 7" 23# K55 New R3 LT&C csg(75 JTS W/RYTWRAP CTG), FS @ 5370', DV tool @ 5417'. Total of 20 centralizers. Halliburton cemented w/total 2800 sks Class "C" & Poz w/additives & 250 sks Cl "C" in two stages. Plug down 11:15 PM 10/22/04. BLM's Paul Swartz notified of planned cement time.

10/28-11/10/04 Drill out DV tool, test casing to 1000 psi for 15 mins- held ok. PBTD 5342'. Perf 5116'-5120', total 10 holes @ 2SPF. Acidize w/2000 gals 20% Hcl. Perf 4598' - 4832', total 24 holes @ 2 SPF. Acidize w/2000 gals 15% Hcl acid. Frac same perfs w/53,760 gals WFG, w/ 35,112 gals 20% HCL, w/4800# 100 mesh sand, 5040 gals cool 15% HCL Run 2 7/8" tbg & rods. Install flowline to existing Gissler A2 Battery. Install pumping unit, turn well to battery.
