Premier Oil and Gas requests approval to change the cementing program on the 8-5/8" casing to 250 sx Class "C" with 4% bentonite and 2% CaCl<sub>2</sub> lead slurry (13.5 ppg, 1.63 cfps, 9.2 gwps) followed by 250 sx Class "C" with 2% CaCl<sub>2</sub> tail slurry (14.8 ppg, 1.35 cfps, 6.37 gwps). Slurry volumes based on 100% excess annular volume between 11" hole and 8-5/8" casing.
