Production casing will be 5 1/2" 17# L-80 LT&C from 13,185' - 8250', then 5 1/2" 17# HCP-110 LT&C from 8250' - 0'.

The 13 3/8" 48# surface casing will either be H-40 or J-55

The 9 5/8" 36# intermediate casing will either be K-55 or J-55
