Please see the below method of water disposal for the two wells on this lease:

- Water on this lease is produced out of the Shugart; Yates formation.
- The Shugart; Yates formation produces 10 bbls of water per day on this lease.
- The water is stored in a 210 bbl tank.
- The water is moved to the disposal facility by being pumped through a 2" PVC line.
- Water is disposed of in Gruy Petroleum Management Co.'s Shugart A Waterflood in Section 29-T18S-R31E, which includes wells Shugart WIW 4 (30-015-05637) and Shugart WIW 9 (30-015-05640). The permit number is WFX-628.

A copy of the water permit is attached.
