3/4/05 - Set 13-3/8" 48# H-40 8rd LT&C casing at 853'. Cemented with 500 sx Halliburton Lite Premium Plus (yld 1.891, wt 12.7). Tailed in with 200 sx Premium Plus (yld 1.345, wt 14.6). Cement circulated to surface. Tested casing to 600 psi for 30 min. WOC 20 hrs and 30 min. Reduced hole to 11" and resumed drilling.

3/8/05 - Set 8-5/8" 32# J-55 ST&C casing at 4100'. Cemented Stage 1 with 125 sx Halliburton Lite Premium Plus + 5# Gilsonite + 1/4# Flocele (yld 1.96, wt 12.5). Tailed in with 200 sx Premium Plus + 2% CaCl2 (yld 1.34, wt 14.8). Stage 2 with 950 sx Halliburton Lite Premium Plus + 5# Gilsonite + 1/4# Flocele (yld 1.96, wt 12.5). Tailed in with 100 sx Premium Plus + 2% CaCl2 (yld 1.34, wt 14.8). Cement circulated to surface. Tested casing to 1000 psi for 30 min. WOC 30 hrs 45 min. Reduced hole to 7-7/8" and resumed drilling.
