The main zones of interest to use the Fluorescene dye are down to a depth of 1600' as per Mr. Jim Goodbar; therefore it is also requested that the dye not be used below 1600'. Mr. Jim Goodbar is in agreement with not running the Fluorescene dye on this well.
