Additional Comments: Closure workplan for Drilling pit. The drilling pit contents will be mixed to stiffen the pit contents. Encapsulation trench will be excavated and lined with a 12 mil. Synthetic liner on former drilling pit site. Drilling pit contents will then be emplaced into the encapsulation trench. A 20 mil. Synthetic liner will then be placed over the pit contents with a min. of a 3' over lap of the under laying trench area. The encapsulation trenches will then backfilled back to grade using a min. of 3' of clean soil and like material. A one call & 48 hour notice will be provide to the Oil Conservation Division before pit closure actions began.

Pit Closure actions to begin by NA. Ending date NA. Mud seed will be applied to former pit area.
