The current worldwide supply/demand ratio and lack of storage capacity is compounded by COVID-19. Our expectation is that the current situation will be temporary in nature. We are requesting the flexibility to maintain the attached list of wells in shut-in status for up to one year. This above lease/unit and the wells to be shut in are capable of producing in paying quantities as evidenced by the most recent production reports. We seek to perpetuate unit leases due to the wells capability to produce in paying quantities and that this cessation of production is temporary. Shut in to begin June 1, 2020. Production will resume when market conditions improve and storage constraints ease.
