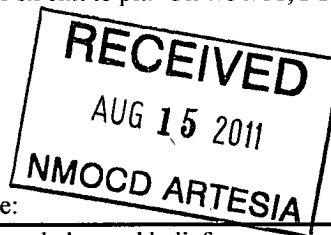

Tailed w/140 sx (188 cf) "C" cmt w/2% Cacl2. Circ 81 sx cmt to pit. On 7/30/11, PT 9-5/8" csg to 1800 psi for 30 min - OK. Resume drilling with 8-3/4" bit.
