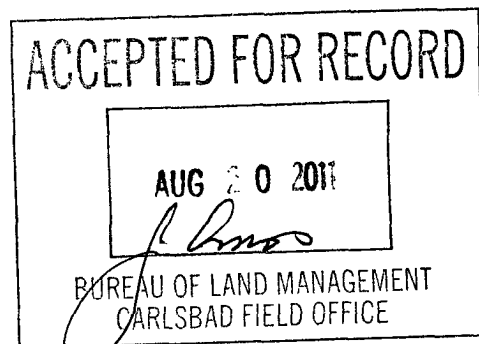
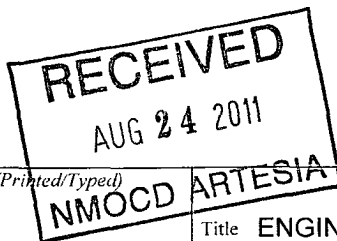
6/24/11 Converted from a water injector to a producer. Flowed well back to tank checking water quality.
