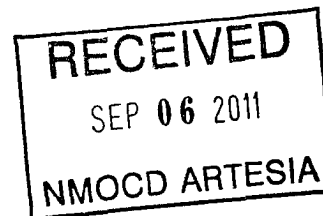

**Existing perforations at 2878'-2882', 3001'-3005', 3030'-3036', & 3111'-3121'**

1. Pull out of hole with rods, pump and tubing
2. Re-perforate existing perforations (2 spf)
3. Perforate new intervals: 2868'-2874', 3072'-3074', & 3132'-3138 (2 spf)
4. Acidize all perforations with +/- 3500 gals 15% HCl acid (75 gal/ft)
5. Flow back well and clean up
6. Run in hole with tubing, rods, and pump
7. Restore well to production and test
