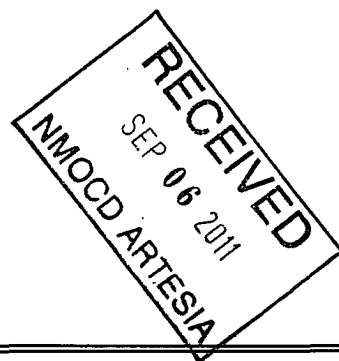
BOPCO, L.P. respectfully requests the changes listed below to be approved for the above captioned well.

Given the PLU 343H is outside both the Secretary's and R-11 Potash areas, BOPCO requests an alteration of the TOC in the 7" casing to 500' into the 9-5/8" shoe set at 3,995'. DV tool will be placed at 4,500'. The changes listed will apply to the second stage only. There will be no change to the first stage. Updated cement additives and volumes are listed below.

Lead - 150 sks EconoCem-HLC + 1% Econolite + 5% Salt + 5 lbm/sk Gilsonite (12 ppg, 2.01 ft3/sk)
Tail - 100 sks HalCem-C (14.8 ppg, 1.33 ft3/sk)
