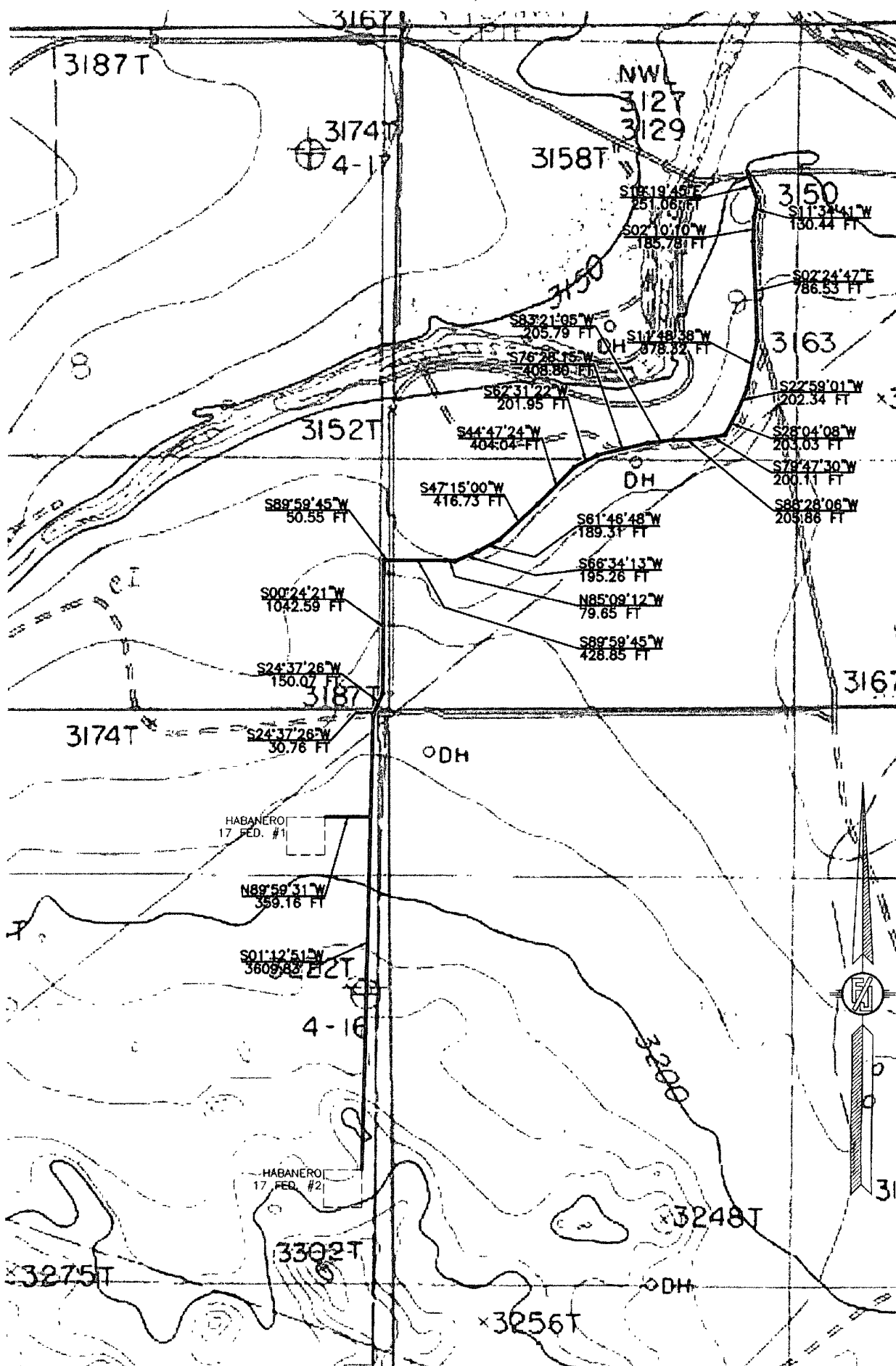

SURVEY NO. 504 5-6 QUAD MAP

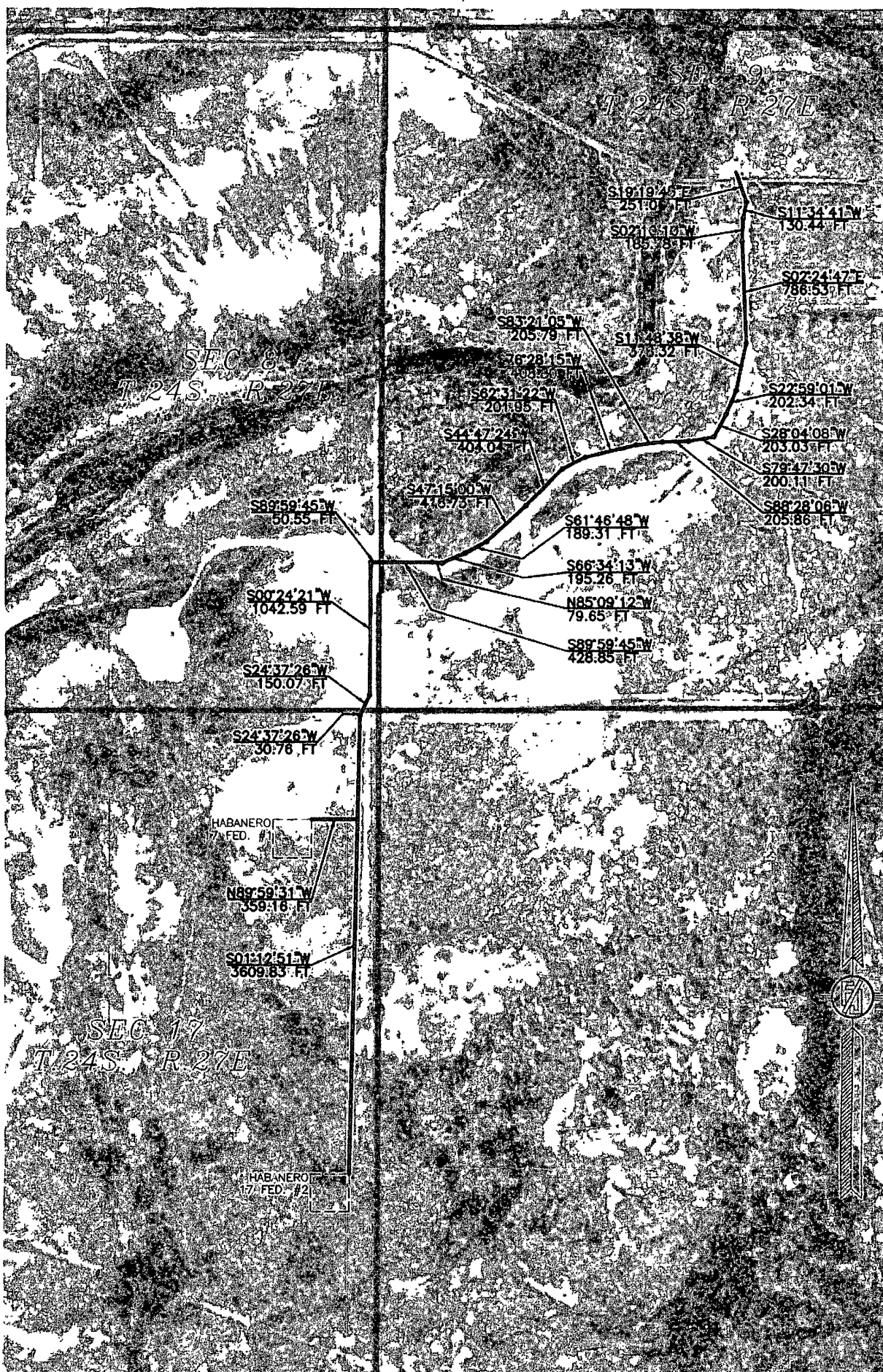
