

An approximate area of 10' X 60'. The flow line was repaired; no oil or produced water was recovered. Impacted soils to be scraped up/excavated and hauled to an NMOC approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chloride delineation/results in soil are for documentation). If initial analytical results for TPH & BTEX are under RRAL's, a Form C-141 Final Report will be submitted to the NMOC requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the NMOC. **Depth to Ground Water: >100' (approximately 184'), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0.**
