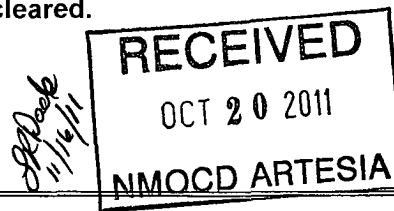

BOPCO, L.P. respectfully wishes to amend the route of the proposed flowline carrying oil, water, and gas from the PLU # 343H located in section 22, T24, R30. The flowline will consist of 3-1/2" steel pipe and will run on the surface. The line will run beside an existing lease road and follow the Twin Wells County road. It will then follow a route behind the stock pens on the west side located at the Twin Wells road. At this point it will follow the BOPCO SWD water transfer line west to just north of the PLU #293 well location, located in section 21, T24, R30. It will then turn south and follow an existing lease road from the PLU #293 to the PLU #261 battery located in section 21, T24, R30. The line will operate at less than 125 psi. Attached is a map of the proposed route. The proposed route has been previously arch cleared.

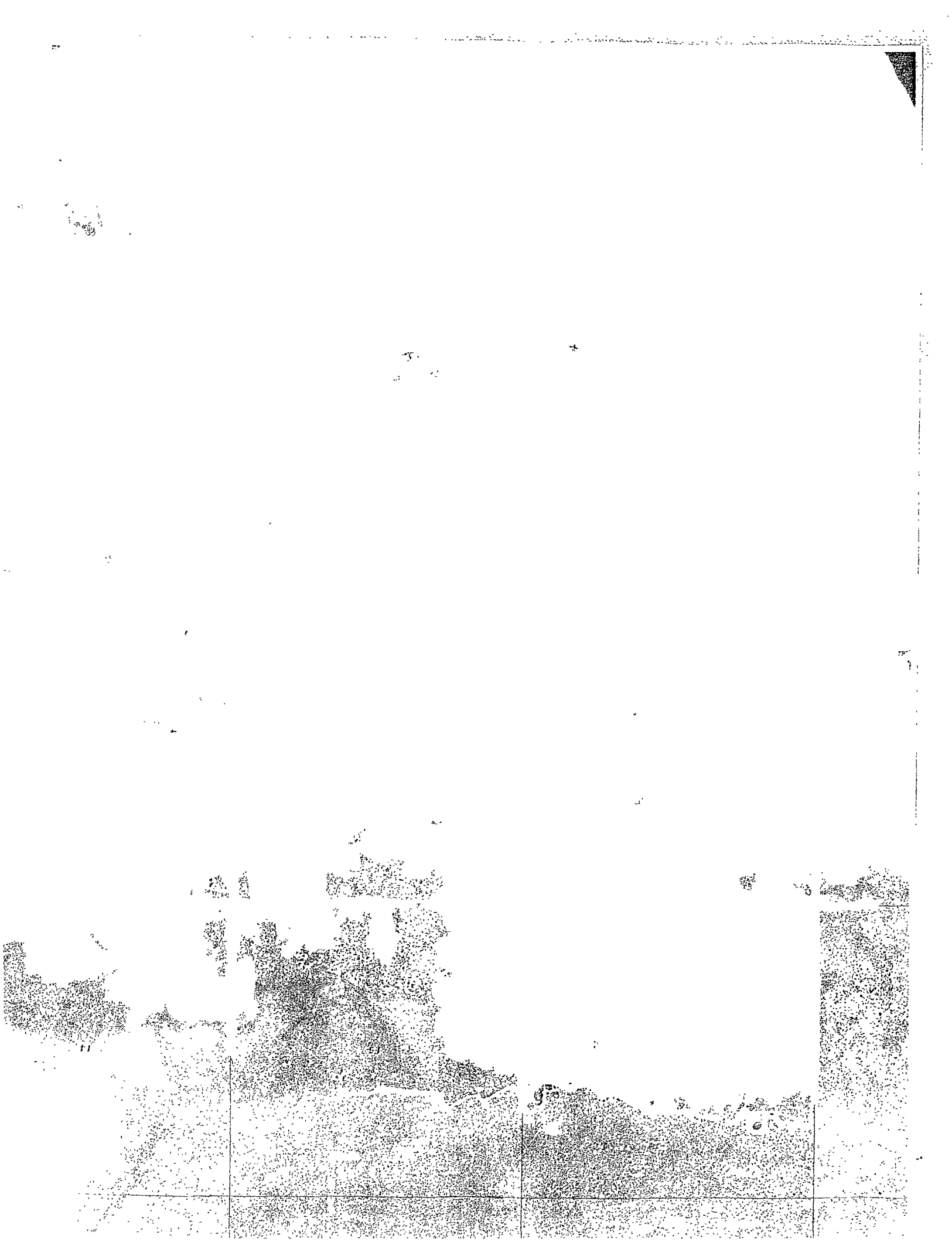

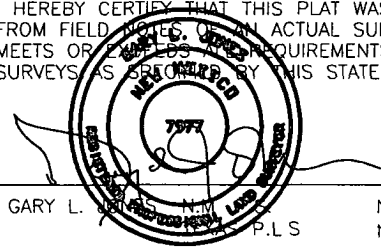
