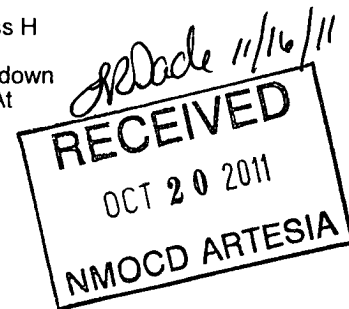

Mixed @ 12.5#/g w/2.16 yd. Tail w/200 sks Class C w/2% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Plug down @ 10:30 AM 10/06/11. Circ 120 sks to pit. WOC 18 hrs. Tested BOPE to 3000# & annular 1500#. At 6:00 PM 10/07/11, tested csg to 1500 for 30 mins, held OK. Drilled out with 8 3/4" bit.
