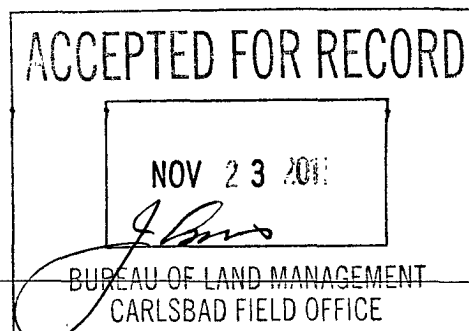
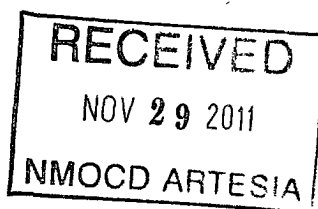

TOOH w/ 131 jts 2-3/8" Salta lined injection tbg. RIH w/ CIBP and set at 4150'. Perforated 3984-3994' (10 holes) and 4018-4028' (10 holes). Acidize new perforations with 2500 gals 15% NEFE HCL acid. Flowed/swabbed well back. Frac'd new perfs w/ 21,000 gals of 20# XL gel and 38,000# 16/30 SLC sand. Flowed well back. RIH w/ bit and clean down to 4140'. RIH w/ tbg and rods. Place well on production.
