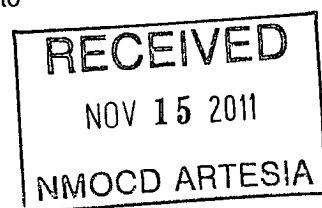

Mixed @ 15.6#/g w/1.19 yd. Plug down @ 1:45 AM 10/17/11. Circ 72 sks cement to pit. WOC 18 hrs. Tested csg spool pack-off to 2500#. Tested BOPE to 3000# & annular 1500#. At 11:30 AM 10/18/11, tested csg to 1500 for 30 mins, held OK. Drilled out with 6 1/8" bit.
