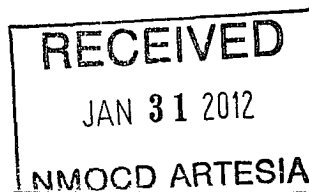

Cmted lead w/175 sx (234 cf) "C" cmt w/2% Cacl2 & 1/8# cello flake & tail w/200 sx (268 cf) "C" cmt w/2% Cacl2. Circ 91 sx cmt to pit. On 1/16/12, pressure tested 8-5/8" csg to 1500 psi for 30 min - OK.
