CBS respectfully request rescission of the previously submitted request to plug and abandon this well on 7-7-2010.

This well has been approved by the State of New Mexico to be converted to a water injection well by NMOCD order PMX-224 expiring on 6-30-2012.

CBS proposes to restore the well pad to an integrity to allow for a well service rig to access the well.

CBS will then enter the wellbore and determine if the mechanical integrity of the wellbore will provide for conversion to a water injection well. If so the well will be converted to water injection. If not CBS will file a plug and abandonment procedure for the well by June 30, 2012.

Conditions of Approval**

- 1. The approval of the plug and abandonment procedure will be rescinded as of December 27, 2011. However, due to non-compliance with that sundry, the operator shall have rigged up on the well to determine if it can be converted by April 30, 2012. This is one month later than required for well 83.**
- 2. Operator has not requested BLM approval to convert this well to an injection well. This is a Federal wellbore and therefore, requires like approval to convert to an injection well.**
- 3. If well cannot be converted to injection, the plugging procedure shall be submitted and plugging scheduled to have the well plugged by July 31, 2012. This is one month later than required for well 83.**
- 4. Operator to be attentive to dates as extensions will only be granted on the plugging portion and will require a date certain from the plugging company.**
