RIH & set 9-5/8" 40# J55 LTC csg @ 4306', cmt w/ 1195sx (398bbl) Light PPC w/ additives, followed by 300sx (71bbl) PPC w/ additives, circ 448sx (150bbl) cmt to surf. WOC. Test BOP's to 250# low, 5000#. WOC per BLM Potash requirements. 4/16/12 RIH & tag cmt @ 4189', circ hole, pressure test csg to 2750# for 30 min, tested good.
