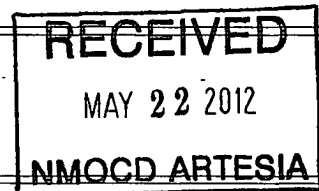

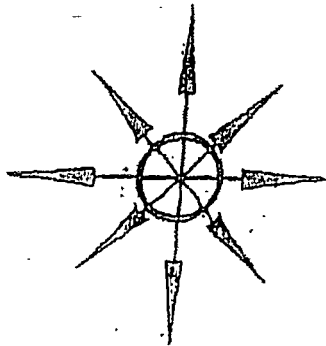

Closed Loop Design Plan

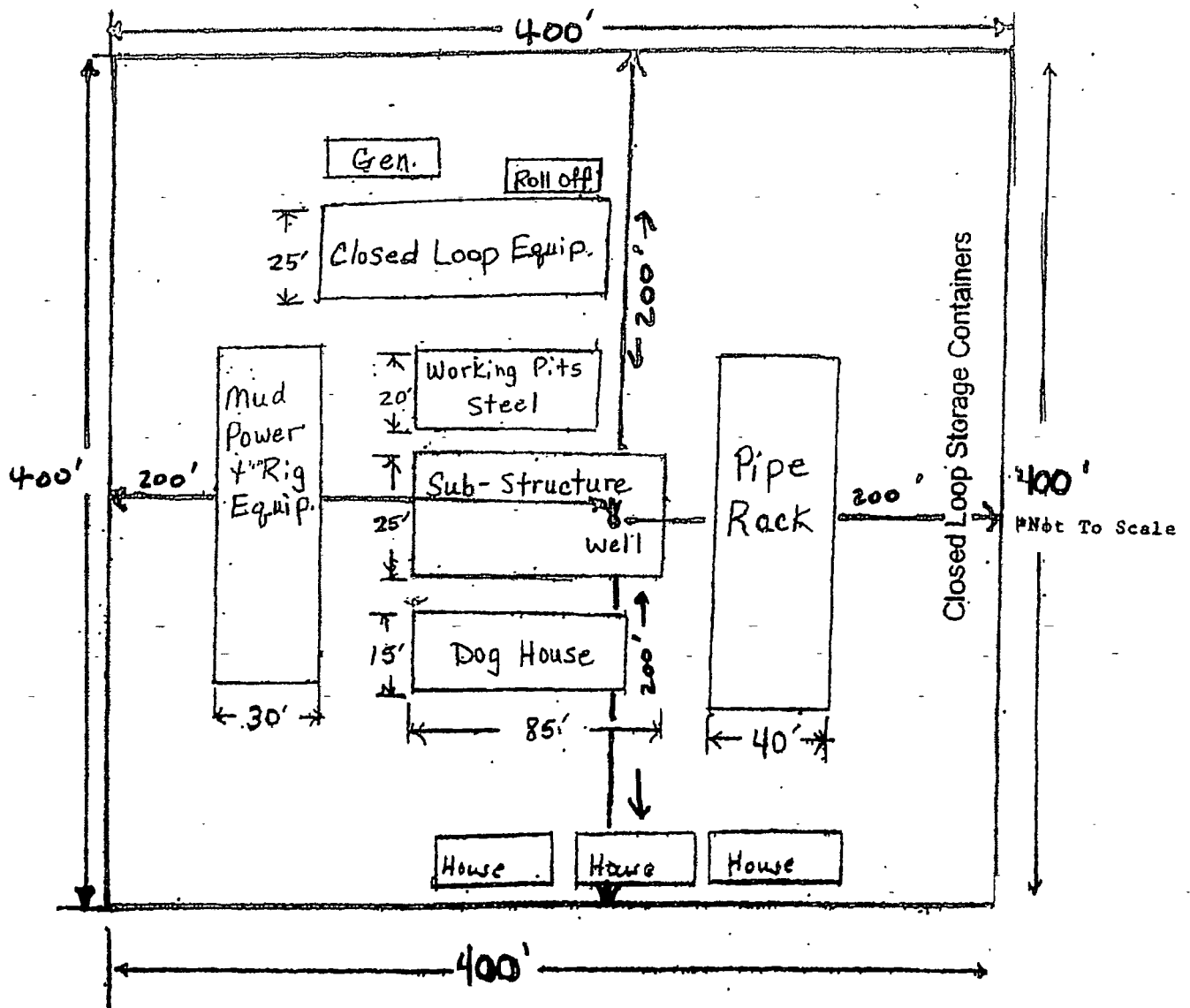
