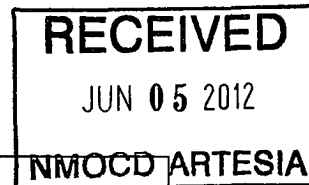

Plan to drill a 17-1/2" hole to 400' with Fresh Water. Run 13-3/8" casing cement with 400 sk toc. Drill 12-1/4" hole to 2300' with Brine water, set 9-5/8" casing cement with 600 sk cement toc 0. Drill 7-7/8" vertical, curve and lateral with cut brine to approx 10500' MD. Run 5 1/2 casing, cement with 750 sk cement TOC 2000
