5/5/2010 Set CIBP @ 3845' and dumped 35' of cement and perforated 2 squeeze holes each at 834' and 143'  
Circulate hole with 56 bbls 9# plugging mud  
Shut down due to pump truck problems

5/6/2010 Break circulation w/ 4 bbls 9# plug mud and pump plug #1 - 35 sx @ 834', WOC and did not tag cement  
Run back in hole and pump 190 sx Class "C" cement to circulate to surface. BLM representative OK'd the job

5/7/2010 Cut off casing below ground level and welded on dry hole marker and filled in the cellar
