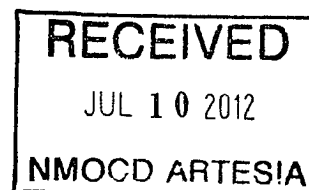

The proposed TD has been revised from 14,500' to 15,000'. Also, the Devonian will be drilled using fresh water instead of cut brine water. (13755' - 15000').
