BOPCO, L.P. respectfully requests the changes listed below to be approved for the above captioned well:

Based on data from the cement bond log ran over the previously set 9-5/8", 40 ppf, J-55, LT&C casing, cement will be circulated to surface on the second stage of the 7", 26 ppf, N-80, LT&C cement job. We circulated 30 bbls of cement to surface off of the DV tool after pumping the first stage and got 60 bbls of cement to surface after pumping the second stage. Actual pumped cement volumes are listed below:

Cement Volumes Stage 1:

235 sx Lead - Class C + additives (10.2 ppg, 2.70 cu ft/sk yield)

120 sx Tail - Class C + additives (13.0 ppg, 1.67 cu ft/sk yield)

Cement Volumes Stage 2:

365 sx Lead - Class C + additives (10.2 ppg, 2.70 cu ft/sk yield)

100 sx Tail - Class C + additives (14.8 ppg, 1.33 cu ft/sk yield)
