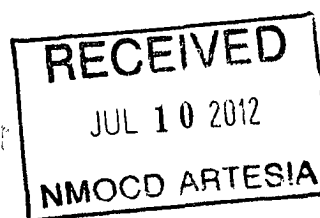
To lay a 4" surface SWD line from the Cotton Draw Unit #153H is located 200 FNL, 1980 FEL of Section 3, T25S-R31E, then west 17 feet, then south 164.45 feet, then east 291.10 feet to a surveyed trunk line located in the NW/4NE/4 of said section.

The spacing for said line will be 30 feet wide by 472.55 feet (28.64 rods), consisting of 0.325 acres.

The line will carry approximately 300 bwpd at 100 psi.

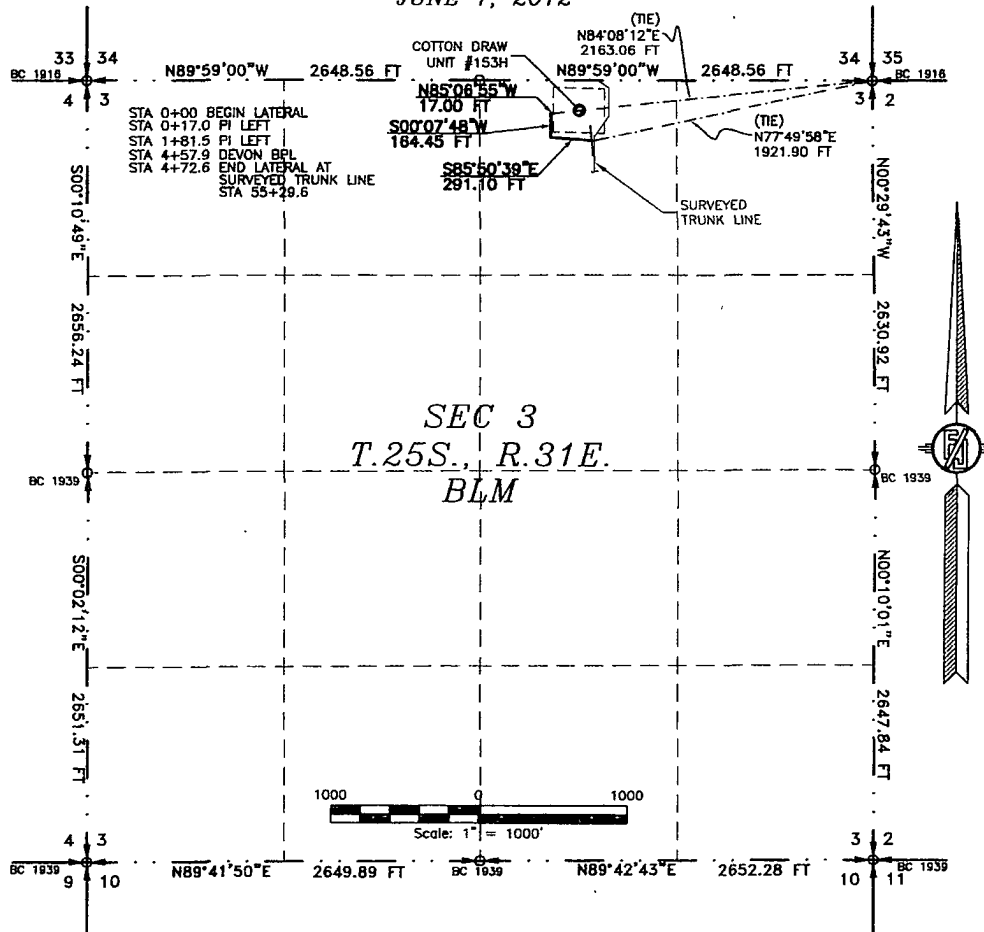

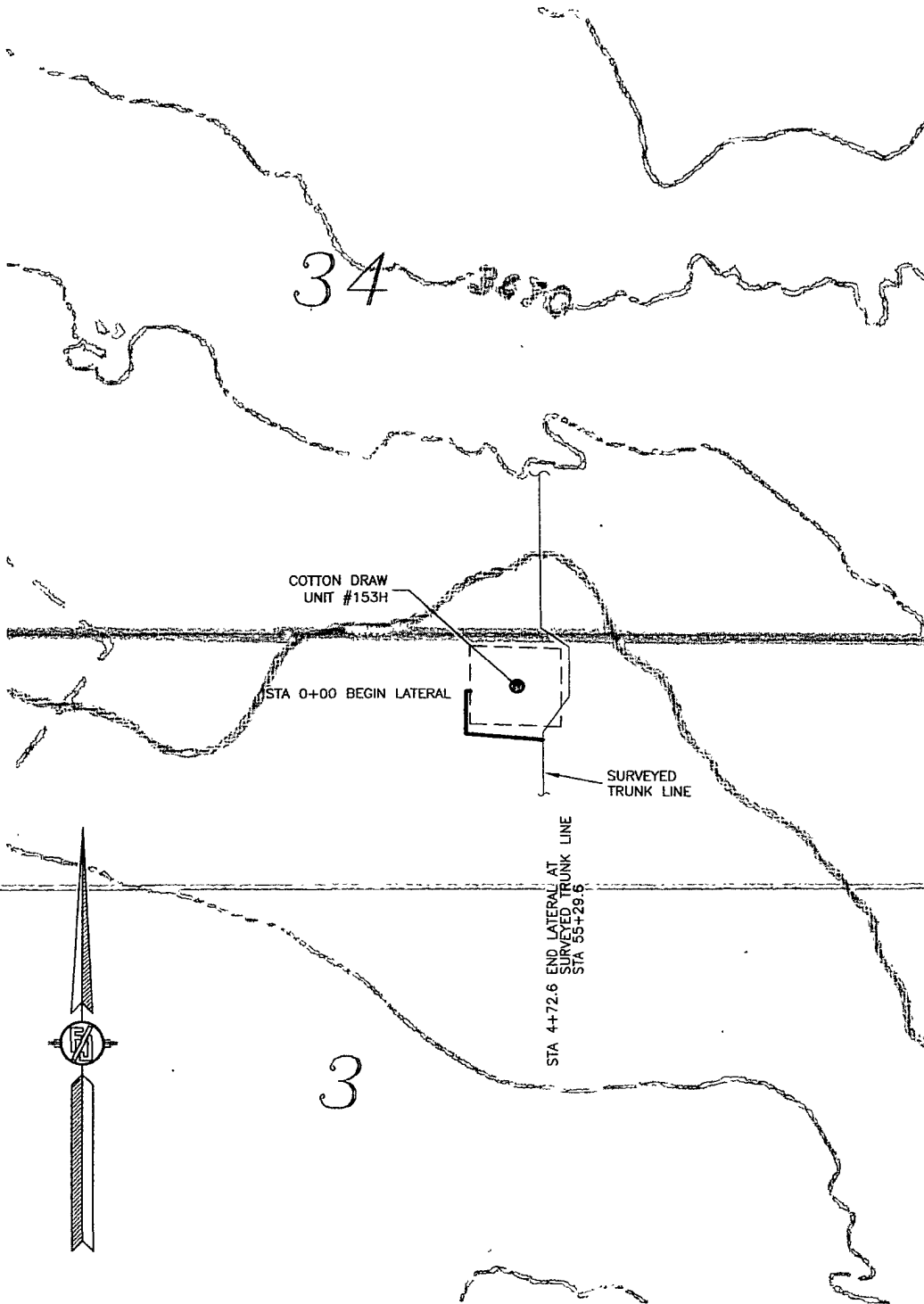
