Change the 4-1/2" liner to a 4-1/2" Baker Hughes completion system utilizing hydraulic set packers for zone isolation. The top of the completion system will be set with a Baker B3 packer, 50' (8,216' MD) into the 7" 26 ppf, N-80, LT&C casing shoe which will be set at 8,266' MD. The 7" casing will be cemented 500' into the 9-5/8" intermediate casing. The liner packer will be isolating the 4-1/2" casing and 17 Baker open hole packers.

Casing Specs: 7" 26 ppf, N-80, LT&C set at 8,266' MD (8,080' TVD) 4-1/2" 11.6 ppf, HCP-110, LT&C set at 13,595' MD (8,212' TVD)
