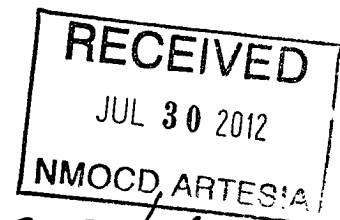

2. Pump Class "C" Cement until full returns to surface
3. POOH with 1" and wait 15 minutes and monitor well for fall back.
4. Top out well with cement
5. Install 4" P & A marker per BLM requirements.

Tag Bottom, circ. cnt to surface.
@ cut-off, 1" cnt to surface all annulus
