7/5/12, drill 12-1/4" hole to 1945', 7/6/12. RIH & set 9-5/8" 40# J55 LTC csg @ 1940', cmt w/ 390sx (1311bbl) Light PPC followed by 250sx (59bbl) PPC w/ additives, circ 143sx (48bbl) cmt to surface. WOC. Test BOP's @ 250# low 5000# high. 7/8/12 RIH & tag cmt @ 1852', circ hole, pressure test csg to 2765# for 30 min, tested good.


