Change the surface location to Unit Letter B, 110' FNL & 2290' FEL, Sec 10, T20S, R25E. The elevation will change to 3422' GL

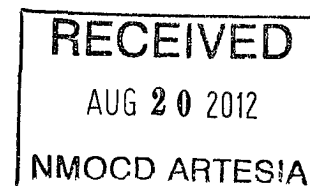
Bottom hole location to Unit letter O, 330' FSL & 2290' FEL, Sec 10, T20S, R25E
