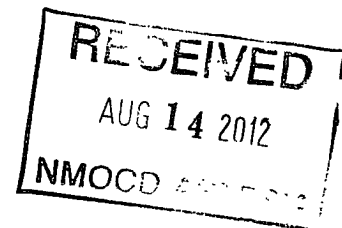

Mixed @ 14.8 #/g w/1.35 yd. Plug down @ 7:30 PM 07/15/12. Circ 97 sks cement to pit. WOC 18 hrs. Tested BOPE to 2000# & Annular to 1500# At 8:30 PM 07/16/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
