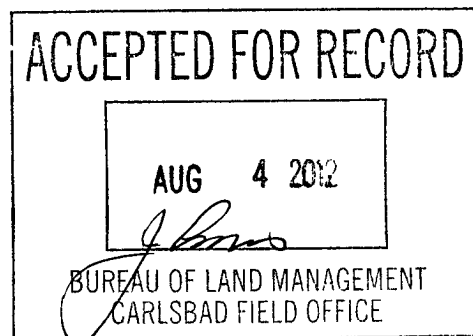
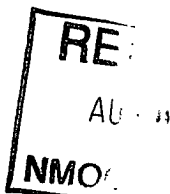

ATTACHMENT TO SUNDRY DATED JULY 11, 2012

On or about March 19, 2012, Snow took samples from both locations to Xenco Laboratories to be tested for chlorides etc. On or about April 17, 2012, Josh Snow, as representative for Snow, met with you to go over what work was to be performed. At this time, both parties agreed to the scope of work to be performed as set forth below:

Duffield 1

1. Contour pit area.
2. Push up diversion berm on high sides of location and pits to facilitate the erosion on West Side of pit.
3. Cap pit area with approximately twelve (12) inches of topsoil caliche mix taken from road nearby as agreed upon.
4. Seed disturbed areas with BLM mix.

Duffield 2

1. Install liner cap over pit area.
2. Downsize location by approximately 80' X 210' and place caliche on liner cap.
3. Cap pit area with approximately twelve (12) inches of topsoil caliche mix taken from road nearby as agreed upon.
4. Seed disturbed areas with BLM mix.
