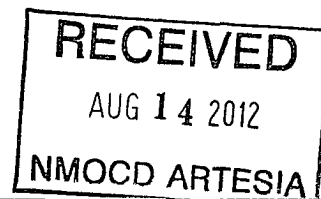

Lead: 975 sks/359 bbls - 35/65 Poz/C + 6% PF20+5% PF44 (BWOW) +ppa PF42 + 0 + .25% PF46 0.125 pps PF29 +1%PF1 (Class C). Yield = 2.07, Density = 12.6

Tail: 200sks/47 bbls of C +0.2% PF13 (Class C). Yield = 1.33, Density = 14.8. Displace w/259 bbls/bump plug @1030/500 psi over, floats ok, 1.5 bbl bleed back - 24 bbl/65 sacks circulated back to surface.
