PT RBP & 5-1/2" csg to 4000 psi for 30 min. Perf additional Glorieta-Yeso @ about 3026'-3234' w/about 40 holes. Frac w/about 85,000# 16/30 sand in X-linked gel. CO after frac, retrieve RBP @ 3250', & CO to ~PBTD3625'. Land 2-7/8" 6.5# J-55 tbg @ about 3570'. Run pump & rods. Release workover rig.
