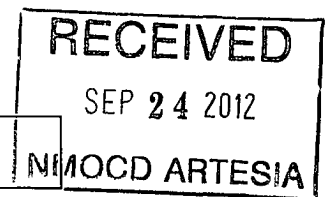
Apache would like to TA this well by setting a CIBP above top perfs and fill hole with packed fluid. We are re-evaluating increased injection and pressure maintenance.
