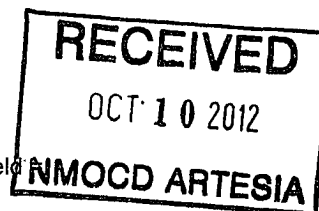

Yield = 2.04, Density = 12.6
