Circ 127 sks cement to pit. WOC 18 hrs. Set wellhead slips w/100k#. Tested csg spool pack-off to 2500#. At 10:30 A.M. 09/10/12, tested csg to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.
