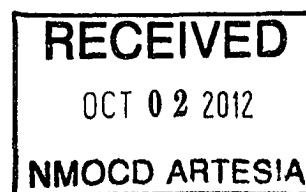

6/12/12 - RIH to 7368'. Pumped 70 bbls hot water down tubing. Cleaned well out to 11,382'.  
6/13/12 - Began pumping down casing with tubing at 8392'. Took 100 bbls to break circulation.  
Pumped another 150 bbls. TIH with tubing to 9204'. Circulated for 2-1/2 hrs getting sand back.  
TIH to 10,024' and circulated for 2 hrs. TIH to 10,865' and circulated 2 hrs. Still getting sand up. TIH to 11,398' below bottom port and circulated 2 hrs. Hole circulated clean. POOH.  
6/14/12 - Set 2-7/8" 6.4# J-55 tubing at 7544'. ND BOP. Turned well to production.
