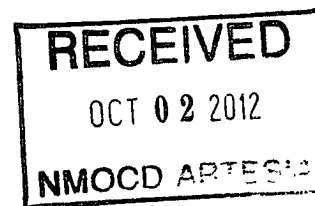

WOC 18 hrs. At 3:00 AM 08/26/12, tested BOPE & csg to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
