Spud (re-enter) well on 10/11/12. Drilled cmt plugs & wash down to 2582' w/8-3/4" bit. PT 9-5/8" csg to 600 psi for 30 min-OK. Continue drilling out cmt plugs & washing down w/8-3/4" bit to 7297'. On 10/14/12, landed 7" 26# L-80 csg @ 7290'. Cmted lead w/185 sx (427 cf) "H" cmt w/5% salt, 0.4% R-3, 5# LCM-1, & 0.2% FL-52. Tailed w/200 sx (250 cf) "H" cmt w/0.5% R-3 & 0.25# CF. Did not circ cmt. On 10/15/12, ran temp survey & found TOC @ 4350'. On 10/15/12, PT 7" csg to 2000 psi for 30 min-OK. Plan to continue drilling to TD.
