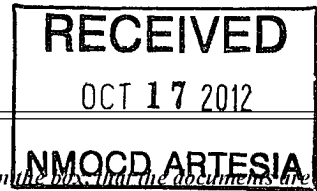

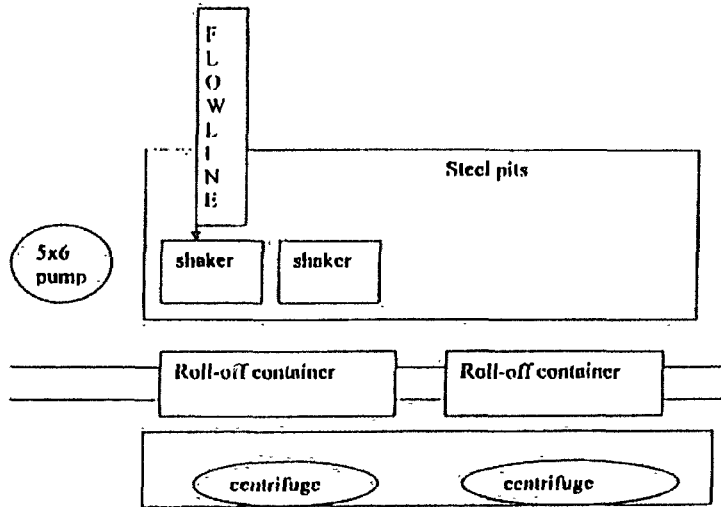

During drilling operations all liquids, drilling fluids and cuttings will be hauled off via CRI equipment to DFP #R9166
