

Cementing

First stage: 450 sks, of pvl, yield 1.47 wt 13.#/drop plug, displace w/160 bbls water, bump plug = 1,100 psi, held for 3 min, bleed off, check floats = held, circulate 76 sks off d.v. tool, good circ thru job

Second stage: lead cement = pump 20 bbls water ahead, 250 sks of 35/65 poz/c, yield 2.04/wt 11.3#,

Tail: 100 sks of pvl, yield 1.47/wt 13.#, shut down, drop plug, displace w/106 bbls water, bump
