4/28/05 – Resumed drilling at 1:30 PM. Set 13-3/8" H-40 48# 8rd LT&C casing at 422'. Cemented with 230 sx Premium Plus (yld 1.347, wt 14.8). Tailed in with 200 sx Premium Plus (yld 1.345, wt 14.8). Cement circulated to surface. WOC. Tested casing to 600 psi for 30 min. WOC 19 hrs. Reduced hole to 12-1/4" and resumed drilling.

5/2/05 – Set 9-5/8" 36# J-55 LT&C casing at 1990'. Cemented with 700 sx Halliburton Lite Premium Plus-SBM (yld 1.981, wt 12.5). Tailed in with 200 sx Premium Plus (yld 1.345, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1500 psi for 30 min. WOC 28 hrs 30 min. Reduced hole to 8-3/4" and resumed drilling.
