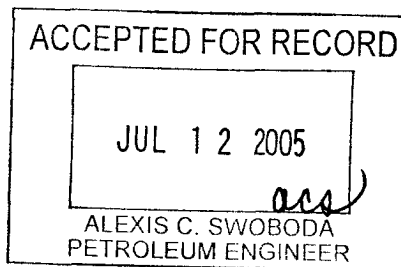

Mixed @ 14.6 #/g with 1.52 cf/sk yd. Followed with 500 sks BJ Lite "C" with additives. Mixed @ 12.5 #/g with 1.98 cf/sk yd. Tail with 200 sks Class "C" with 2% CaCl2. Mixed @ 14.8 #/g with 1.34 cf/sk yd. Plug down at 12:01 pm 06/26/05. Did not circulate. WOC 6 hrs. Ran 1" pipe and tag @ 110'.
Set 1st Plug with 25 sks "C" with 2% CaCl2. WOC. Tag @ 75'.
